Tenants Rights Class

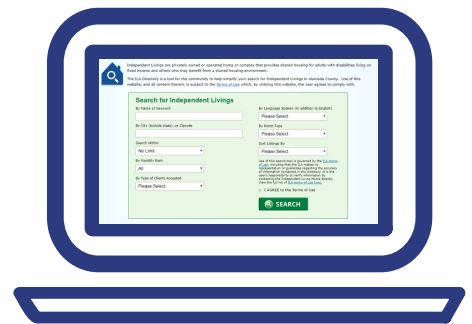
