# **Garza Independent Living**

#### **General House Rules:**

- 1. No smoking inside Garza Independent Living
- 2. No illegal drugs or alcohol in or around Garza Independent Living
- 3. No stealing or destruction of property.
- 4. No violence or possession/use of weapons including, but not limited to, guns or explosives in or around **Garza Independent Living**
- 5. Pets are not allowed. Please discuss with the Operator, Antolin Garza, if you would like to request special permission for a pet.

### **Chores and Responsibilities**

- 6. Tenants are expected to make up his/her own bed daily.
- 7. Tenants are expected to do his/her laundry weekly following the **Garza Independent Living Laundry Schedule**
- 8. Tenants are expected to follow weekly chore list posted in the **kitchen**.
- 9. Tenants are expected to maintain proper hygiene (i.e. take showers regularly, brush teeth daily).

#### Meals and Food

- 10. Label all personal food with your name.
- 11. All dishes must be washed after use.
- 12. Eating is allowed only in the **kitchen and living room**.

# **Visiting Hours**

- 13. Tenants are responsible for the actions of their guests.
- 14. Visiting Hours are from **11:00 AM to 7:00 PM.** (Visitors are not to disrupt other tenants from utilizing common areas).
- 15. No Overnight Guests are permitted.

### **Medication Management & Medical Emergencies**

- 16. **Garza Independent Living** requires all tenants to fill out the Behavioral Health Emergency Response Plan (ERP) form.
- 17. Every tenant is responsible for his/her medication and contact with their doctors.
- 18. If Antolin Garza isn't on site, contact him at **(559) 304-9090.** If you are unable to reach Antolin Garza call 9-1-1.
- 19. No transportation is provided by **Garza Independent Living** to and from the tenant's doctor's office or clinic.

# Earthquake/Fire/Disasters

- 20. In case of earthquake/fire/other natural disasters, tenants will leave the house immediately through the nearest exit. Move away from the house and use a cell phone or neighbor's phone to call 9-1-1.
- 21. In case of fire, call 9-1-1

# **Pest Prevention**

- 22. Prior to moving belongings into their shared space, all new tenants are required to wash all clothing and other items.
- 23. Antolin Garza will inspect all clothing, bedding and other washable items before tenant is permitted to move into his/her space.
- 24. If at any point you think you may have bed bugs, notify Antolin Garza immediately so that they can begin treating the problem.

### **Professional Conduct and Behavior**

**Garza Independent Living** houses a group of adults living together as a family.

- 25. Tenants are expected to treat each other like family; with dignity and respect at all times.
- 26. Abuse and harassment will not be tolerated.
- 27. No sexual conduct within Garza Independent Living
- 28. No fighting or abusive language.

#### **Rule Violation**

All tenants are expected to follow House Rules while residing at **Garza Independent Living**. A copy of these rules are posted in the **Living/Kitchen area** for your convenience. Breaking any of the house rules may result in your eviction from **Garza Independent Living** 

### **Grievance/Complaint Procedures**

Grievances and complaints may be brought to Antolin Garza either verbally or in writing. He will respond to the grievance or complaint within **72 Hours**. If the issue is still not resolved, Antolin Garza will inform tenant of recommended actions.
