

Blossom Trail

General House Rules:

- 1. No smoking inside Blossom Trail
- 2. No illegal drugs or alcohol in or around Blossom Trail.
- 3. No stealing or destruction of property.
- 4. No violence or possession/use of weapons including, but not limited to, guns or explosives in or around Blossom Trail.
- 5. Pets are not allowed. Please discuss with the Blossom Trail / Joyce Montgomery if you would like to request special permission for a pet.

Chores and Responsibilities

- 6. Tenants are expected to make up his/her own bed daily.
- 7. Tenants are expected to do his/her laundry weekly following the Blossom Trail Laundry Schedule between the hours of 8am to 8pm.
- 8. Tenants are expected to follow weekly chore list posted in the kitchen.
- 9. Tenants are expected to maintain proper hygiene (i.e. take showers regularly, brush teeth daily).

Meals and Food

- 10. Label all personal food with your name.
- 11. All dishes must be washed after use.
- 12. Eating is allowed only in the dining room.

Visiting Hours

- 13. Tenants are responsible for the actions of their guests.
- 14. Visiting Hours are from 11am to 6pm
- 15. No Overnight Guests are permitted.

Medication Management & Medical Emergencies

- 16. Blossom Trail requires all tenants to fill out the Behavioral Health Emergency Response Plan (ERP) form.
- 17. Every tenant is responsible for his/her medication and contact with their doctors.
- 18. If Joyce isn't on site, contact her at 559-907-4481. If you're unable to reach Joyce call 9-1-1.
- 19. No transportation is provided by Blossom Trail to and from the tenant's doctor's office or clinic.

Earthquake/Fire/Disasters

- 20. In case of earthquake/fire/other natural disasters, tenants will leave the house immediately through the nearest exit. Move away from the house and use a cell phone or neighbor's phone to call 9-1-1.
- 21. In case of fire, call 9-1-1

Pest Prevention

- 22. Prior to moving belongings into their shared space, all new tenants are required to wash all clothing and other items.
- 23. Joyce Montgomery will inspect all clothing, bedding and other washable items before tenant is permitted to move into his/her space.
- 24. If at any point you think you may have bed bugs, notify Joyce Montgomery immediately so that they can begin treating the problem.



Professional Conduct and Behavior

Blossom Trail houses a group of adults living together as a family.

- 25. Tenants are expected to treat each other like family; with dignity and respect at all times.
- 26. Abuse and harassment will not be tolerated.
- 27. No sexual conduct within Blossom Trail.
- 28. No fighting or abusive language.

Rule Violation

All tenants are expected to follow House Rules while residing at Blossom Trail. A copy of these rules are posted in the common area for your convenience. Breaking any of the house rules may result in your eviction from Blossom Trail.

Grievance/Complaint Procedures

Grievances and complaints may be brought to Joyce Montgomery either verbally or in writing. Joyce will respond to the grievance or complaint within 7 to 10 days. If the issue is still not resolved, Joyce will inform tenant of recommended actions.
